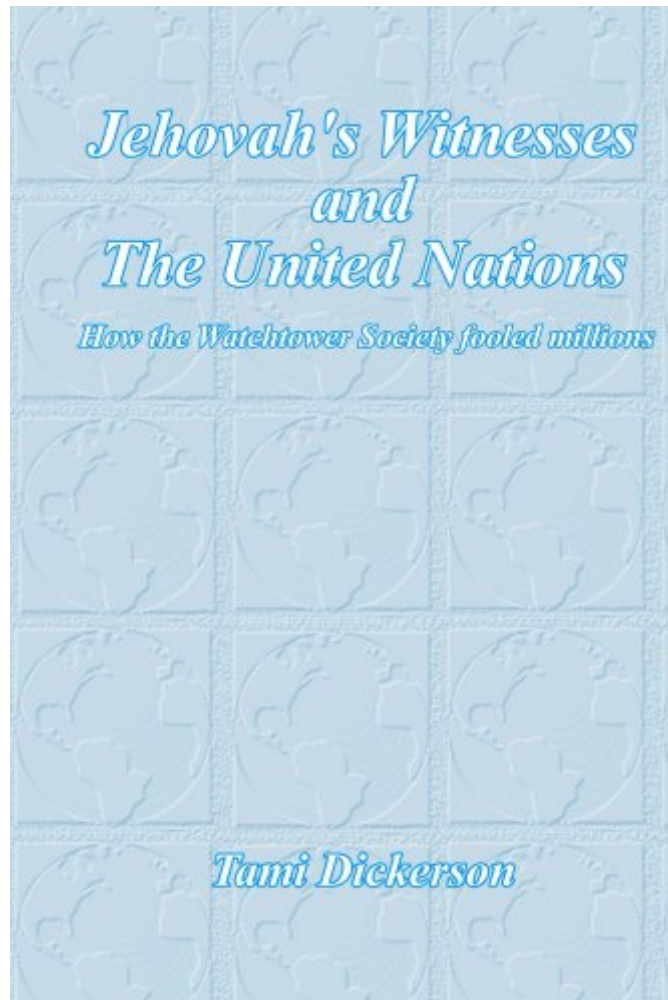

Why have I only just discovered this now? I started studying the bible with JW's in 1991 (the year the watchtower Society joined the UN.) Now, over 20 years later, I discover that while I was turning my life inside out and upside down in 1991, being rejected by my family, "persecuted" for my faith and much more, the Watchtower Society was joining the "disgusting thing that causes desolation" (according to their interpretation of Jesus' words.) While I was walking away from so called "false religion" and getting baptised, they were joining the ranks of the "Babylonish Whore" and riding the

To say that this last paragraph is duplicitous in nature is an understatement. So the most damning evidence against the Watchtower Society is in its own publications, irrespective of any other documentation. And it makes a sham of their defence that they weren't aware of the implications of their membership, and it was all just for a library pass anyway (to access works which could easily have been obtained by other means.) Try telling that to the thousands of faithful men and women in Malawi who were gang-raped, beaten and killed in the most horrendous ways in the 1960s and 70s for not carrying a 25c political card - a trifling matter when compared to the entire Watchtower organisation joining the Big Daddy of global political organisations. Perhaps the most chilling line in the whole book is toward the end - on page 64: "And, even after all this time the Watchtower Society has still failed to apologize to all the members who have been hurt or shunned by this affair. It has still failed to be honest about this situation." I guess we are collateral damage? How could anybody ever trust another word from this man-made organisation?

For this purpose the Watchtower September 8, 1991 (reproduced on page 15 of book) cleverly wrote an article paving the way for association (a requirement to produce certain proof's) that any prospective NGO applicants had to demonstrate a friendly disposition toward the UN Charter and Activities (Belief system) in which the article was entitled "The United Nations--A

Better Way?" It was cleverly written towards the United Nations and its future using wording like "play a major role"... "developments will be very exciting"... and "do some astonishing things that may well amaze you". The author says: [The reality, though, is that Jehovah's Witnesses will actually see these words for what they really are: Veiled references to their doctrinal view that the United Nations is the image of the beast of Revelation who will be given authority for a short time before God's Kingdom comes to destroy it (The Watchtower, September 1 1989 p.7). This ambiguous wording allowed the writer to play to both sides of the field. A deceptive ploy, but well done.] The book clearly makes the point even though the "governing body" and a number of "others involved at Bethel New York and other countries branches KNEW", does NOT mean rank and file "all other Jehovah's Witnesses" would have known of this intention and subsequent involvement as it unfolded and given the wording above both the United Nations and the average Jehovah's Witness were FOOLED; as the Preview and the book Title points out was the effect of this type of deception, which continued through ALL the years after granted NGO Status. Once it became "Public Knowledge" the Watchtower went into "Damage Control", firstly making a vague response to the Paper and sending a "letter internally" to serve a similar purpose and any whom talked about it or researched it (outside what the society stated about itself) were in effect to be "disfellowshipped" and from there "shunned" to silence dissent and "keep facts concealed". Luke 12:2 The NEW YORK Watchtower affiliation seemingly occurred in 1992 and lasted neigh on ten years before it was exposed in the "Guardian" UK Newspaper which triggered a WORLD WIDE RESPONSE which ultamedly meant many Jehovah's Witnesses at the "Doors" may be confronted with this hypocritical association. The main defence by the Watchtower basically pleaded ignorance to what was involved and when it was brought to their attention of what involved then a "parting of the ways resulted". The author however found the "weight of evidence outlined" in book did NOT support this representation and in fact was designed to further mislead to "save face" and make it sound like they became NGO's in ignorance. This type of pattern has been repeated on numerous occasions to conceal it's own misbehaviour's when found out and the tactic is always to (isolate those whom find out from other Jehovah's Witnesses saying Elders are handling matters) and once handled use their favourite labell "Opposes or Apostates" to (freeze JW's minds) and to further prevent enquiry then "SHUN Victims" and this means "Silencing Them" so none in the congregation will have anything to do with them effectively "concealing the cover up" by (controlling what version JW's are allowed to listen to) showing they disown the Truth by their OWN ACTIONS OF DECEPTION like the Pharisee's in Christ's Day. The book is NOT vindictive but sticks to the facts as found out by enquiry to BOTH SIDES. The author a JW was determined to PROVE the Watchtower right and checked all

The author Tami traced the "REAL REASON" to (NGO PRIVILEGES) which went to "PARTICIPATION" in (RELEVANT INTERNATIONAL CONFERENCES) held by United Nations. Chapter 6 of book goes into relevant details to PROVE this "PARTICIPATION" occurred by giving examples anyone may check up to prove this was the case.
