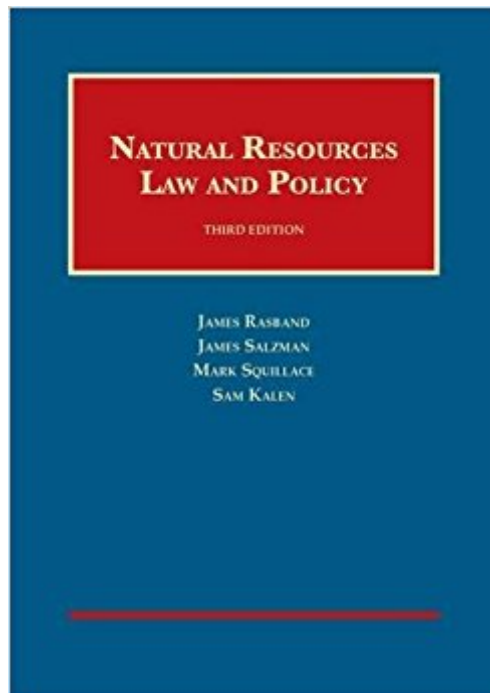

The book also considers natural resource law and management on both public lands and private property, as well as in international settings.
