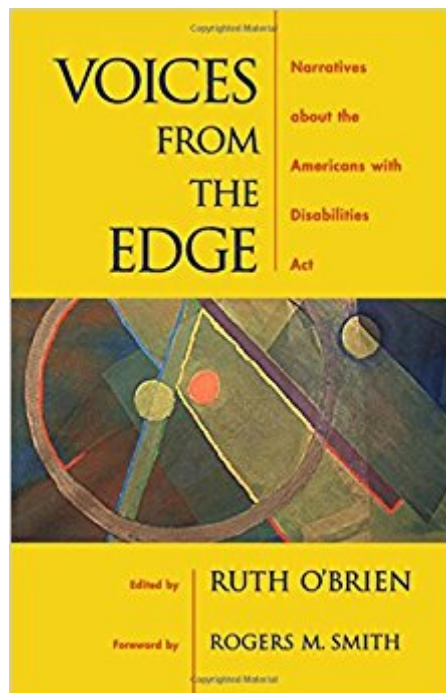

The book was good in showing how far the American Disabilities Act would go in applying to various cases of discrimination that can be claimed.
