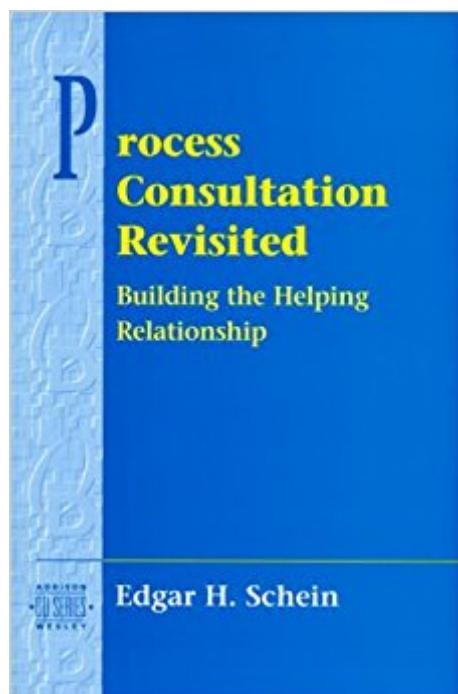

Edgar H. Schein is the Sloan Fellows Professor of Management Emeritus and Senior Lecturer at MIT's Sloan School of Management. He started his education at the University of Chicago, received his B.A. and M.A. from Stanford University, and earned his Ph.D. in social psychology at Harvard University in 1952. Dr. Schein has published several books, including *Process Consultation, Volume I: Its Role in Organization Development* (1972, 2nd edition 1988), *Career Dynamics* (1978), *Organizational Psychology* (1980), *Organizational Culture and Leadership* (1985 2nd edition 1992), *Career Anchors: Discovering your Real Values* (1985) and *Process Consultation, Volume II: Lessons for Managers and Consultants* (1987), as well as numerous journal articles. He is a Fellow of the Academy of Management and the American Psychological Association, he has been a management and organization development consultant to many corporations and government agencies in the United States and abroad.

Ed Schein's book gives a very nice and easy to understand intro to Process consultation. It should be read by more consultants out there. I found his formulations simple and easy to understand and easily recognizable. I have sometimes wondered why I do the things I do in a certain matter - now I
